For over 15 years, she has held various leadership roles dedicated to driving innovative programs in BAMSI's Community Living and Day Services division. With expertise in personcentered planning, social inclusion strategies, and leadership development, she has become a recognized advocate for breaking down barriers and fostering meaningful connections that promote social inclusion.

It is a true privilege to lead such a highly regarded organization, known for its dedicated staff and unwavering commitment to supporting people with disabilities in leading full, meaningful lives within their communities."
